- 2) Advanced Design




1) PARTNERSHIP APPLICATION

- Monitoring of application opportunities
 - Analysis and reporting of the main opportunities identified
 - Establishment of contacts with the lead partner of the project
 - Acquisition of the project abstract
- Identification and collection of administrative documents
 - Control of relevant legal aspects
 - Budget negotiation
 - Sending the required documentation

2) Advanced Design

LINEA 3: Project Management


